Registration Form for Lifeguard Training, Lifeguard Instructor, Water Safety Instructor

- What to Bring: Two towels, swimsuit, snack & drink (bring lunch or lunch money if a full day course), Payment for remaining balance and registration confirmation email.
- How to Register: Checks payable to CHARLOTTE SAFETY TRAINING (Deposit or Full Payment is required to register – see deposit amounts below. **Deposits are non-refundable.** Registrations will be confirmed by email once processed. Please read below for additional information.

- Payment Methods: Checks, Cash, Money Orders and Credit Cards accepted for all registrations *EXCEPTION: (Payments for one week courses made on first day of course must be made by Cash, Money Order or Credit Card). Payments for recertification courses received the DAY OF the course must be paid in Cash, Money Order or Credit Card.*

Class Information and Policies

- **ALL participants must pass a pre-requisite swimming test and be at least 15 years old to be eligible to take the Lifeguarding course.** Part 1 – the “300”: The swim is 300 yards non stop -100 yards freestyle with a supportive kick and rotary breathing – FACE IN WATER, 100 yards breaststroke with a pull-breath-kick-glide motion, 100 yards freestyle or breaststroke (swim goggles allowed for this portion). Part 2 – the “Brick”: Candidates must swim 20 yards to retrieve a 10 pound object from 7 feet of water and return to starting position within 100 seconds (no swim goggles allowed for this portion). Part 3 – “Treading Water”: Candidates must tread water for 2 minutes with their hands placed underneath their armpits keeping their heads clear of the water in a manner that allows for comfortable breathing. **If you think that there is a chance that you will not be able to complete the pre-course swim, make an appointment for a swim test before class begins. Deposits are not refunded for failure to successfully complete the precourse session (deposit may be applied to a future course).**
 - **Lifeguard Course** - Students must score a minimum of 80% on both written tests (Lifeguard Training, CPR Pro with AED and First Aid), PLUS, perform all rescue skills up to the course standard to receive a passing grade in the Lifeguard Course. Participants must be on-time, and attend ALL class sessions.
 - **W.S.I. Course** – Students must complete the online precourse session, score at least 80% on all written tests, and successfully demonstrate practice teaching and swimming skills to pass the W.S.I. course. All classes must be attended (Please see WSI FACT Sheet for course prerequisites).
 - **Lifeguard Instructor Course** – Candidates must successfully meet the prerequisite requirements and have a good working knowledge of the Lifeguard program to take this course. Please reference the Lifeguard Instructor FACT sheet for exact course requirements. Candidates must also score at least 80% on the Lifeguard instructor written exam and complete all practice teaching assignments. All classes must be attended.
 - We do not schedule make up classes. In all of our courses, all scheduled class sessions must be attended. If a class is missed, you must enroll in another course and take the entire course over again. A \$100 fee may be required to re-take or reschedule a Lifeguard Course (depends on situation). For all Instructor courses the full course fee may be required.
 - Course dates and times are subject to change at any time.
 - We will take a 30-45 minute lunch break on all full day courses. Students have the option of bringing their lunch or leaving the facility for lunch. The CCS Swim & Tennis Center location has a refrigerator, microwave and toaster oven that is accessible to students if needed.
 - Please be certain that you want to take the class before you register. If you pre-paid the full amount and you cannot meet the prerequisites for the course, you will be entitled to a refund of your class fees minus the deposit amount, as deposits are non-refundable.
 - All participants may come in for a FREE class review for the life of their certification cards.
 - CST rents pool space at the CCS Swim & Tennis center, YWCA Central Carolinas, SwimMac Carolina, and all other pools we use. The classes are offered through Charlotte Safety Training. **Please call Charlotte Safety Training for questions or concerns about the class or to register for a class.**
 - **IMPORTANT – PLEASE READ** – Certificates are now issued electronically via email link directly from the Red Cross. Please specify which email address you want used on the registration form. Certificate link is good for 2 years – feel free to access and print copies as needed.
 - The American Red Cross Lifeguard Training, Lifeguard Instructor, and Water Safety Instructor courses require strenuous physical activity. Please be certain that you are capable of this type of activity before registering. If the candidate has asthma or any other condition that may be induced with physical activity be sure to let us know under the notes section of this registration form. Include any information on symptoms and medications and how to administer if needed.
- Lifeguard Instructor Course** (L.G.I. certification plus all Books and Pool fees) -\$425 – *Does NOT include \$35 fee to Red Cross for precourse session*
- \$100 deposit required to register if not paying full amount in advance (deposit amount of \$100 is non refundable).
 - LGI Registrations must be completed 2 weeks prior to the start date of the course.
- Water Safety Instructor** (Includes F.I.T. & WSI Certification, plus all Books and Pool fees) - \$325
- \$100 deposit required to register if not paying full amount in advance (deposit amount of \$100 is non refundable).
